PETITION FOR ADJUDICATION OF THE CURRENT EXPENSE BUDGET FOR THE FISCAL YEAR 1 JULY 2025 TO 30 JUNE 2026

COME NOW the duly elected, qualified, and acting commissioners of the Casper- Alcova Irrigation District ("District" or "CAID") of Mills, Wyoming, according to and in conformance with Wyo. Stat. Ann. § 41-7-402(b), and hereby present to the Court this *Petition for Adjudication of the Current Expense Budget for the Fiscal Year 1 July 2025 to 30 June 2026*, and respectfully show to the Court as follows:

- 1. All of the estimated expense items set forth in this petition were approved by unanimous vote during the regular meeting of the Board of Commissioners of the District on May 8, 2025. Certain explanatory parentheticals are provided for the Court's further information in italic typeface; please note that the Board did not vote on the language of these explanatory parentheticals, although it voted on the associated expense line-items.
- 2. The following is an itemized estimate of the money to be raised by assessment, or otherwise, within the District for the purpose of constructing new work, maintenance, to meet the yearly expenses during the fiscal year, and to provide for possible delinquencies:

- 3. There are a total of 548 owners of lots, tracts, and farm units of irrigable land within CAID. The "first acre" of each of the 548 landowners shall be assessed a Facilities and Maintenance Fee of \$600.00, which equals a sum of \$328,800.00.
- 4. There are 24,228 acres of irrigable land situated within CAID. To cover the budget for the 2025-26 fiscal year, after utilizing other funding, it is necessary to assess said acreage (minus the 548 "first acres") at the rate of \$36.00 per acre:

5. It may be necessary on occasion for the District to transfer money from one line item of the budget to another to meet unforeseen expenses. The District should be authorized to do that without further order of the Court so long as the overall budget remains intact or the unforeseen expenses can be paid in accordance with the Court's Order.

WHEREFORE, THE CAID COMMISSIONERS PRAY that the Court:

- 1. Fix a time and place to examine CAID's budget and hear all objections thereto, and
- 2. Approve CAID's budget, adjudicate the same by order, and authorize an assessment for the 2025-2026 fiscal year as follows:
