**ORDER SETTING HEARING ON PETITION FOR ADJUDICATION OF THE
CURRENT EXPENSE BUDGET
FOR THE FISCAL YEAR 1 JULY 2024 TO 30 JUNE 2025**

THIS MATTER came before the Court on the *Petition for Adjudication of the Current Expense Budget for the Fiscal Year July 1, 2024 to June 30, 2025* filed by Casper-Alcova Irrigation District (“CAID” or the “District”) on June 4, 2024 (the “2024 Budget Petition”). The Court, taking notice of the filing and pursuant to Wyo. Stat. Ann. § 41-7-402 and this Court’s Order dated August 17, 2023, hereby **ORDERS AS FOLLOWS**:

1. **NOTICE IS GIVEN** that on Thursday August 1, 2024 at 2:00 p.m., or as soon thereafter as the matter can be heard, the 2024 Budget Petition is hereby set for hearing for thirty (30) minutes before Judge Kerri M. Johnson in the District Court, 115 North Center Street, Casper, Wyoming, 82601. Anyone participating in this hearing must be present in person unless prior approval is obtained from the judge at least 48 hours in advance.

2. Notice of the time and place of said hearing shall be published in the Casper Star-Tribune for at least four (4) consecutive weeks prior to the hearing date.


3. Any written objections to the 2024 Budget Petition shall be in writing and filed no later than five (5) days prior to the hearing on the budget.

4. Casper-Alcova Irrigation District shall display this notice on its website and in its principal office.

5. If counsel desires the proceedings to be reported, arrangements for a court reporter's service must be made three (3) days in advance by the attorney concerned.

6. This matter shall not be vacated or continued upon stipulation of counsel, but a vacation or continuance may only be allowed by order of the Court for good cause presented in writing.
